The prices are calculated per person/per night. The monthly payment is determined as a multiple of the price per person/night and the number of days in the given month.

The local residence fee may be added to the price of accommodation, according to the current legislation of the Czech Republic.

In the event that the resident ceases to be a student under a valid accommodation contract (besides the regular completion of studies by graduating from the degree program), the price of accommodation will be increased by 25 % until the next change of study status or expiry of the Accommodation Contract.

In the event that the resident violates the rules for termination of accommodation pursuant to Article III, paragraph 9, letter h) of the Accommodation Contract, the price of accommodation will be increased by 50 % for each day that exceeds the reported date of termination of accommodation.

In case of free capacity, between November and August, it is possible to accommodate only one student in a double room. In such cases, the price of accommodation is increased by 40 % for the second unoccupied bed.

4) The amount of the contractual penalty depends on the estimated cost of repair. Payment of the contractual fine does not affect the accommodation provider's right to recover actual damage.

5) If the resident violates the smoking ban and causes a false call of the emergency services, the costs associated with this will be paid in addition to the contractual penalty.

Methods of payment for accommodation (including deposit and services payments):

- a) Payment by collection – resident sets this up on the portal <https://iskam.czu.cz> and at their bank.
- b) Direct transfer – resident makes a direct transfer to the account of CULS (**Account No. 500022222/0800**). Indicates the variable symbol (**VS**) **817501** for the identification of the payment. As specific symbol (**SS**) indicates the student identification number (**UIN**)(**UIČ**).
- c) For international payments use following bank data of CULS:

- d) Payment by debit/credit card or cash at the university cash desk at the CZU Library building
- e) Online payment through the university payment portal after logging into the portal <https://iskam.czu.cz> and clicking the icon “Pay by card”
