Study-related Fees

Determination of the General Fees for Study in the Czech study programs at the Faculty

Fees for study at the FTA/CZU are generally governed by the "Statute of the CZU Prague", "Procedure for Setting of Fees for Study" and the "Amount of fees for the relevant academic year" which are available HERE. Current fees for studies related to study at the faculty can also be found in the enclosed document below.

Fees for extended studies, which must be paid by a Bachelor's or a Master's student who studies in Czech study program longer than the standard length of study increased by one year (3+1 for the Bachelor's program, 2+1 for the Master's program) are further governed by the rules available HERE.

Determination of the Fees for Study in a Foreign Language at the Faculty of Tropical AgriSciences

The amount of tuition fees in a study program conducted in a foreign language, according to Article 58 (4) of the Act, (hereafter referred to as "the Fees for study in a foreign language") is determined by taking into account the economic requirements of study, the cost of quality assurance and the current situation in a similar field of education as follows:



Type of Study Programme	Valid for the Study Programmes	Fees in CZK for each year of study commenced
Bachelor's	International Cooperation in Agriculture and Rural Development	7 000,-
Master's	All subsequent Master's degree programmes in a foreign language, except for the programme: Tropical Farming Systems	5 000,-
Master's	Tropical Farming Systems	40 000,-
Doctor's	All doctoral study programmes in a foreign language except for the programme: Agriculture in Tropics and Subtropics	5 000,-
Doctor's	Agriculture in Tropics and Subtropics	80 000,-

The amount of the Fees for students who study in a Bachelor's degree programme in International Cooperation in Agriculture and Rural Development is hereby increased to 40,000 CZK for each year of study exceeding the standard length of study, which is 4 years in a Bachelor's degree programme. Included in this calculation are any other Bachelor's degree programmes of study in the Czech Republic, which were terminated other than properly.

The amount of the Fees for students who study in a Master's degree programme is hereby increased to 40,000 CZK for each year of study exceeding the standard length of study, which is 3 years in a Master's degree programme. Included in this calculation are any other Master's degree programmes of study in the Czech Republic, which were terminated other than properly.



The Dean or a Deputy Dean of the Faculty chosen by him shall assess study Fees in a foreign language according to paragraphs 1, 2 and 3 of this Article and said Fees shall fall due before the date of enrolment in the study programme or before the date of enrolment in higher education. The Fees for studying in a foreign language are non-returnable.

When paying Fees for study in a foreign language, the student must correctly fill in both the specific and variable payment symbols according to the information provided in the University Information System. Banking charges are paid by the student.

The Dean or a Deputy Dean chosen by him may reduce the amount of the Fees up to the level of the Fees that were valid in the academic year in which the student was first enrolled for study. The issuance of any decision in relation to this paragraph shall be in accordance with Section 68 paragraph (3) of the Act as the basis of any proceedings.
